WEB TERMS AND CONDITIONS

General Conditions for the use of Lexland S.L's Website

Purpose:

These general conditions regulate the use (including the mere access) of the website ("LEXLAND ABOGADOS"), including all content and services made available there (within the site "LEXLAND ABOGADOS"). Any person accessing the site LEXLAND ABOGADOS ("a User") agrees to abide by the General Conditions which are in force at any time you access the site LEXLAND ABOGADOS.

The content and services available to Lexland Abogados users on the site Lexland Abogados (respectively, the "Contents" and "Services") may also be regulated by Special conditions that, in case of conflict, prevail over the general conditions (Special Conditions"). The user agrees that anytime they use the Content or Services that relevant Special Conditions may apply.

As a consequence, the user must carefully read the general conditions every time he intends to use the site LEXLAND ABOGADOS, as well as the relevant Special Conditions every time they intend to use the Content or Services in question.

Using Lexland Abogados Site:

The site LEXLAND ABOGADOS is not a source of advice or a means of establishing a professional relationship, or any other relationship between client and lawyer.

The user acknowledges and voluntarily and expressly agrees that the use of the Site LEXLAND ABOGADOS is done under their sole responsibility. PERSONAL DATA

By the mere fact of visiting the Site LEXLAND ABOGADOS, any personal data identifying the user is not automatically registered. However, there is certain non-personal and non identifiable information which is collected and recorded in the Internet servers of LEXLAND ABOGADOS (for example, type of browser, user’s operating system, IP address from which you access the website of LEXLAND ABOGADOS) in order to improve the navigation for users and the management of the LEXLAND ABOGADOS Site.

Google Analytics is free analytics tool from Google that helps to the web site owners to understand how visitors interact with your website. Google analytics collects information anonymously and, as if it will track footprints in the sand, reports on website trends without identifying individual visitors. Google Analytics uses its own cookie to track visitor's interaction. The cookie is used to store information, like the time that the current visit occurred, whether the visitor had been previously on the site or the site it came from. Google Analytics' customers can access a variety of reports about the way the visitors interact with their website, so that they can improve them and made them more traceable. It uses a different cookie for each Website and we do not track visitors across multiple sites.

It uses a different cookie for each web site and do not track visitors across multiple sites.
